LAW ENFORCEMENT RISK REVIEW PROCESS

The North Carolina League of Municipalities (NCLM) Law Enforcement Risk Review Process is a program designed to assess a police department's adherence to best practices, court decisions, and policies and procedures related to high-liability activities in law enforcement. The goal is to mitigate liability exposures, enhance officer safety, and validate that training and operating procedures meet industry standards. It is <u>FREE</u> for members of the NCLM Property & Casualty Trust.

The North Carolina Association of Chiefs of Police supports the risk review. It is designed and continually peer-reviewed in collaboration with the NCLM Chief Advisory Committee, representing Police Chiefs across North Carolina's law enforcement agencies. The Risk Review contains over forty risk categories, each developed with prioritized risk dimensions used for evaluation. The process specifically addresses adherence to best practices related to policy, training, supervision, performance management, and oversight. The Risk Review is not intended to be a version of accreditation or a replacement but to work in unison with accreditation programs.

The Review Process

1. Initial Risk Review Presentation NCLM staff meets with the municipality's Manager and Police Chief to review the process categories and dimensions.

2. Agency Internal Review

This internal review process allows the agency to make any changes needed to meet the best-practices category dimensions. Its length depends on the on the department's pace.

3. NCLM Policy Review

The municipality submits its policies and category alignments to NCLM staff for review. This portion takes place off-site.

4. NCLM Site Operations Survey

This survey includes an officer ride-along and critical personnel interviews, site review and survey, policy-practice validation for 1-2 days.

5. Final Validation

Upon completion of the self-audit, NCLM off- and on-site reviews and surveys, and any final policy revisions, NCLM staff will present a plaque to the Manager and Police Chief before the City or Town Council. Media release provided.
